

- **Power of attorneys to register** in the IES.
- Power of attorneys to act in the IES within the scope of utilisation of services of GAZ-SYSTEM S.A. for submitting applications for transmission contract, capacity allocation (PP) and transmission ability allocation (PZ).
- Power of Attorney for Administrator within organisation (AWO) who is responsible for managing all Users accounts, modifying user roles for people in your organisation.
- Current extract from the National Court Register.

CONCLUSION OF THE TRANSMISSION CONTRACT

Applicant shall submit together with the application for transmission contract, the scans of the following documents and certificates, or copies thereof authenticated by individuals authorized to represent the entity, or a legal counsel or attorney:



- documents confirming the legal status of the activity carried out by the Applicant, including a
 current extract from the relevant commercial registered obtained in accordance with the principles specified
 in the regulations of the country where the Applicant has its registered office (issued not earlier than 3 months
 before);
- power of attorneys (PoAs) or other documents confirming the right of the individuals who represent the Applicant to incur obligations on its behalf (unless such right can be inferred from the content of the document referred above) and POAs for the persons authorised to represent the Applicant in the procedure of concluding capacity allocation via the IES and/or GSA;
- licence promise/excerpt of the licence or a declaration signed by persons authorised to represent the Applicant that the activities carried out by the Applicant do not require a licence under the Energy Law;

In addition to the documents referred above, an Applicant without a registered office in Poland shall also present the sworn translation to the Polish language of the documents which are not executed in the Polish language.
