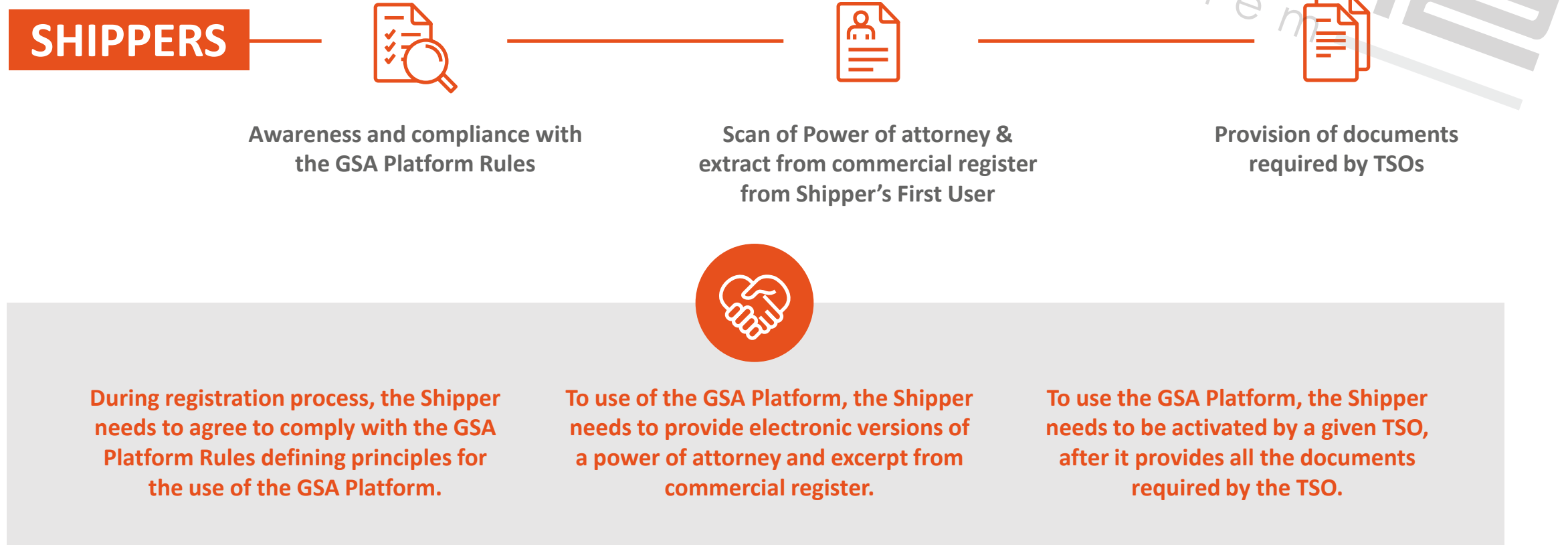

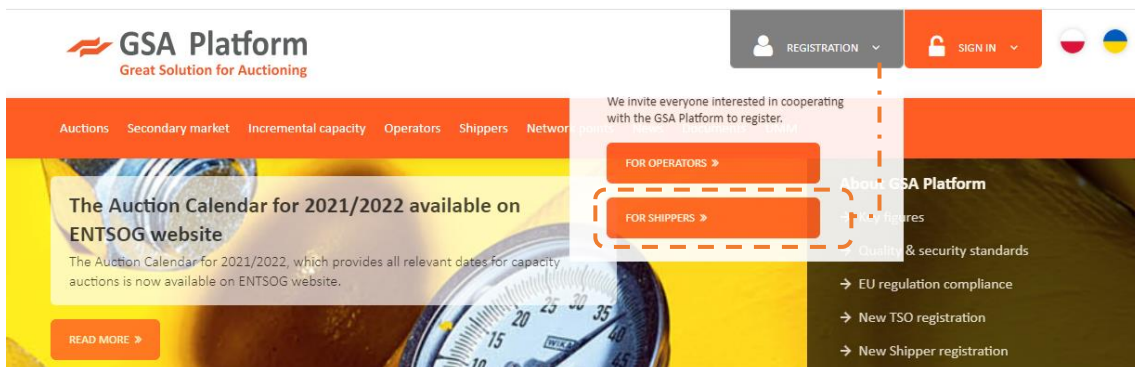

Step 5

Delivery of the registration documents

In order to complete the registration process, scans of the required registration documents should be sent to aukcje@gsaplatform.eu i.e.:

- power of attorney to register on the GSA Platform (only for the first User)
- current copy of the extract from National Court Register



Step 6

Activation of the account

After receiving the documents, the GSA Platform Administrator activates the account, simultaneously generating an e-mail notification to the User about the possibility of logging on to the system. The First User receives the role of the Organisation Administrator (AO)



Each next user within an organisation also should register on the GSA by entering their organisation's EIC code on the first page of the registration form. Then the Organisation Administrator should accept the new account, and thereafter the account will be activated by the GSA Platform Team.

HOW TO GET THE PERMISSIONS TO TAKE PART IN AUCTIONS

- ❖ The System User has to fulfill the operator's requirements for obtaining allowance to participate in its auctions.
- ❖ The System User should during registration (or later) send a request via GSA Platform (STEP 2 of the Registration proces) to the operator concerned for an auction/ secondary market/market demand assesement. When certain requirements are met, the operator concerned accepts System User request.

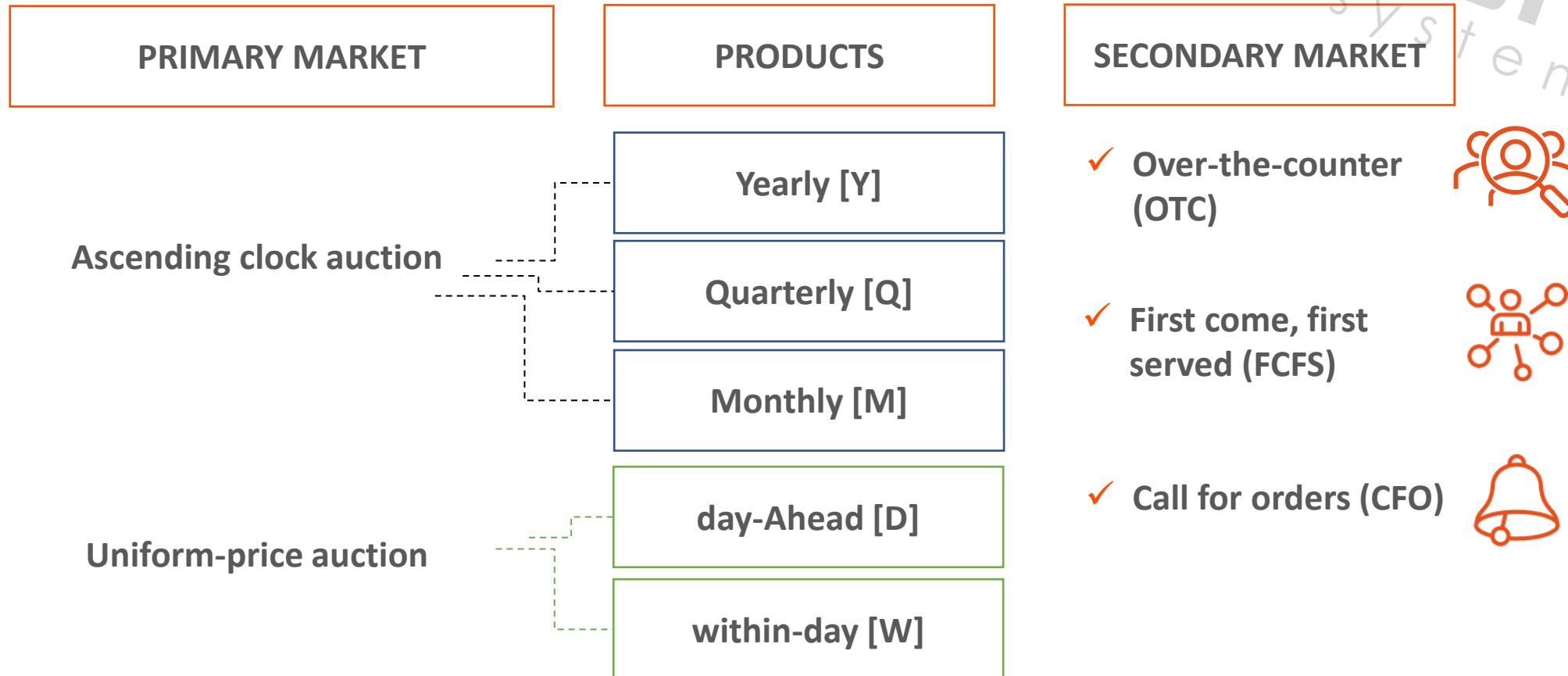

ASCENDING CLOCK AUCTION (Y, Q, M)

Auctions rounds starts at 9:00 a.m

Course of the rounds:

- ❖ First round (**R1**) – lasts 3 hours
- ❖ Subsequent rounds(**Rn**) – lasting 1 hour each
- ❖ Breaks between rounds last 1 hour each

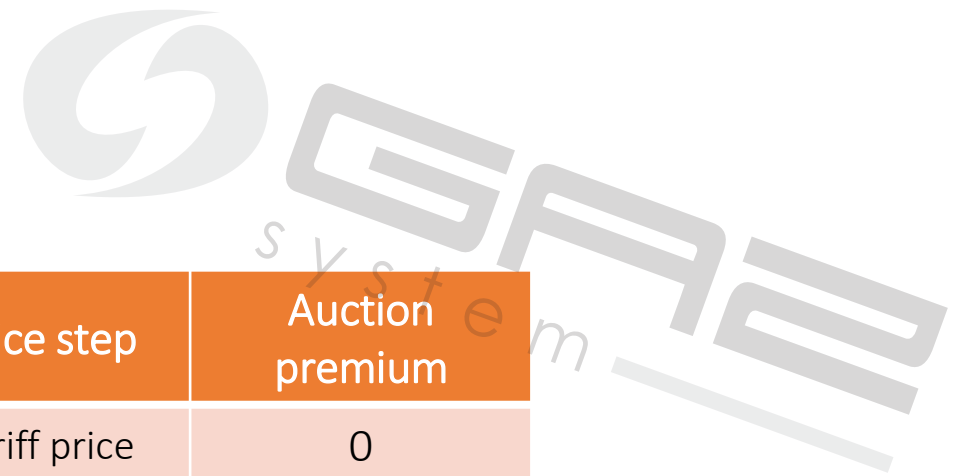
In the auction for a given product and entry/exit point, the entitled user places a bid for the capacity User wishes to purchase in a given auction round.

Bids may be freely amended and withdrawn during the ongoing bidding round. The last bid at the end of a bidding round is binding.

In order to participate in a subsequent bidding round it is necessary to have submitted a bid in the previous bidding round.

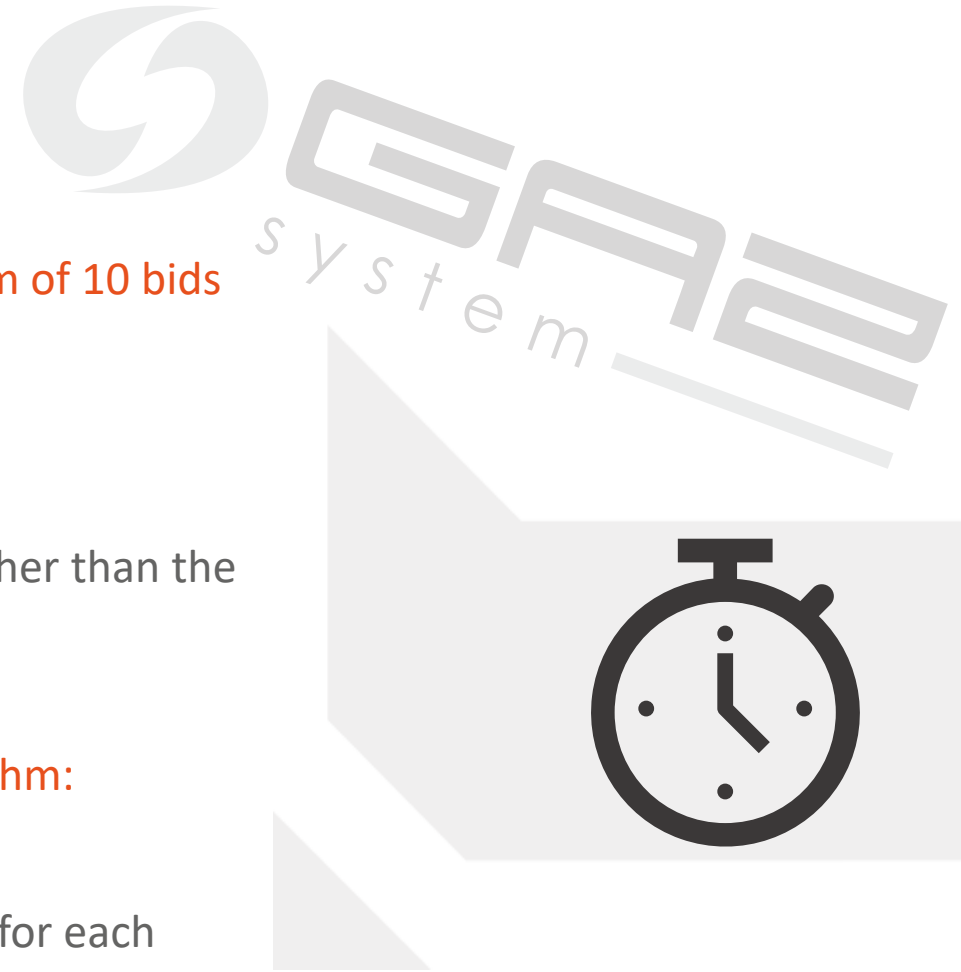
Auction lasts **30 minutes**.

An Auction participant for each auctioned product may submit a maximum of 10 bids containing:

- ❖ the minimum amount of capacity the participant is interested in,
- ❖ the maximum amount of capacity the participant is interested in,
- ❖ the maximum price he is willing to pay for the capacity (equal to or higher than the tariff price).

After the round, the bids are considered according to the following algorithm:

- ❖ Ranked according to the price bid,
- ❖ The bid with the lowest price accepted - determines the clearing price for each participant in the auction,
- ❖ For bids with the same price accepted as the clearing price, the capacity shall be determined in proportion to the value submitted in the bid.



At the top of the form, there is an auction identifier: **Auction – auction ID:** auction number. When a round is active, the round field shows the round status as **Running: [x.y]** where x is the consecutive number of the large round and y is the consecutive number of the *small* round (during the break, this field shows On break: [x.y]). Additionally, the adjacent field shows whether this is a large step (**L**) or small step (**S**) round. The From-To field shows the round/break duration. The Time remaining field displays the time in minutes remaining until the end of the round.

- ❖ It is not possible to bid during an auction break (no Bid button available). But it is possible to preview the amount of auction premium from the previous and next round as well as already bid capacity and other auction details.
- ❖ Large step rounds of an auction lasts until the total capacity bid by all auction participants is lower than the capacity offered. When such situation occurs, the given large round is marked as Cancelled, and auction goes to small step rounds. Maximum of 4 small rounds are possible.

COMFORT BID IN ASCENDING CLOCK AUCTION (Y, Q, M)

When User wants to use the Comfort bid option in long-term auctions, he should click “**Comfort bid**” button during the large price step bidding process and then, in the lower area of the Comfort bid section, check **Apply comfort bid** and enter the requested capacity and value in the Maximum surcharge field. Then confirm it by clicking “**Save**” button.

AUCTION SUMMARY AND FORMER AUCTION PREVIEW

- ❖ When the auction ends, it is possible to find/preview an auction with a given ID in the historical auctions section. It receives the Finished status.

SECONDARY MARKET- TYPES OF OFFERS

The Seller reselling the Capacity on the secondary market shall choose one of the three available procedures before the publication of the offer:

1.



over-the-counter (OTC) offer

an offer, which may be accepted only by a one Shipper with appropriate rights to the secondary market defined by the Seller during preparation of the given OTC offer. The Buyer cannot modify the OTC offer – may accept or reject the OTC offer.

2.



call for orders (CFO) offer

an offer, which may be accepted by all Shippers with appropriate rights to the secondary market who were indicated by the Seller during preparation of the given CFO offer.




first come, first served (FCFS) offer





an offer, which may be accepted only by a one Shipper or group of the Shippers indicated by the Seller during preparation of the given FCFS offer. The Seller may address the FCFS offer to the selected one or more Shippers or to all Shippers with appropriate rights to the secondary market. The first Shipper (Buyer) who accepts the FCFS offer closes the offer to other Shippers. The Buyer may accept the FCFS offer in whole or in part

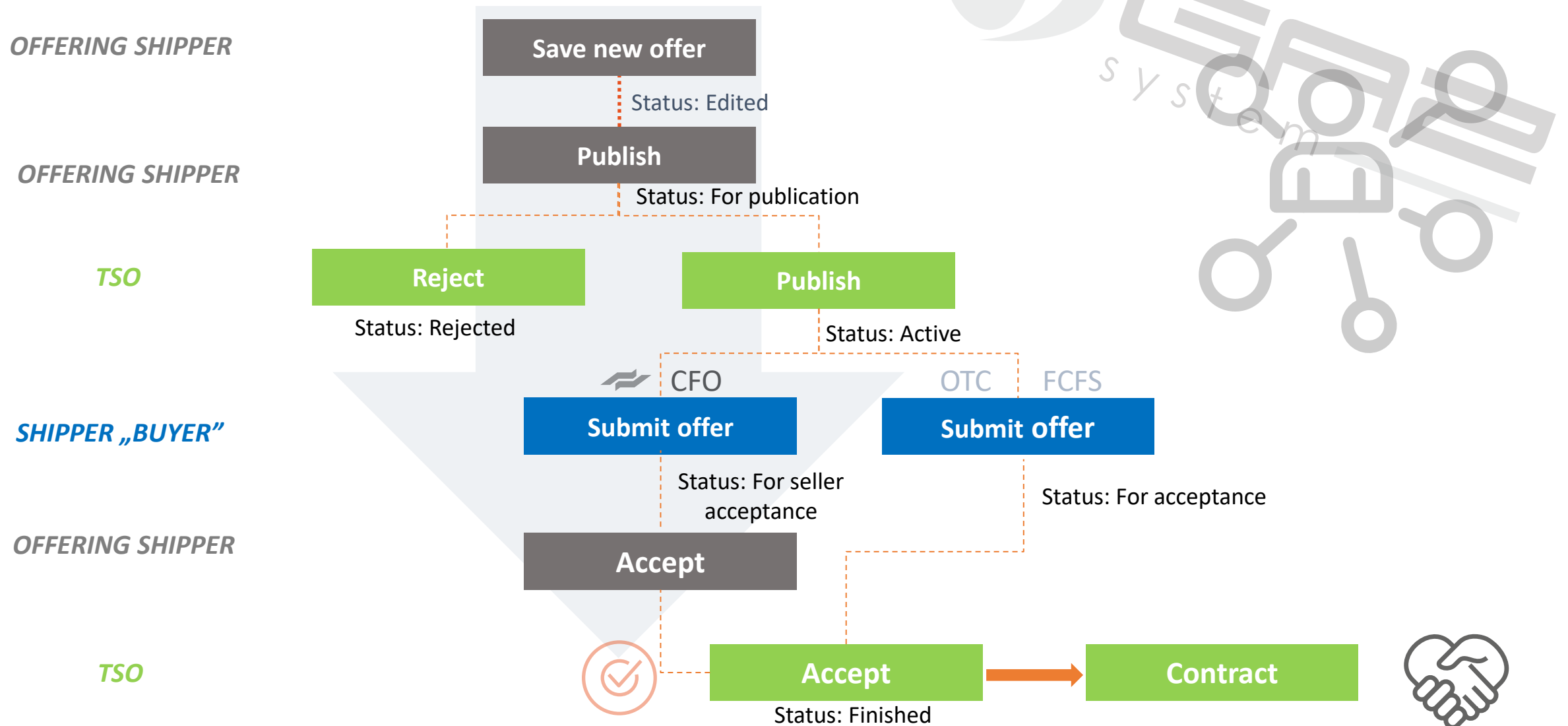
