<sup>1</sup> For the restricted capacity booked at the interconnection point between the Lithuanian Natural Gas Transmission System and the Belarusian Natural Gas Transmission System (Gas Metering Point: Kotlovka Gas Metering Station (hereinafter – GMS)) by using which the right to transport natural gas only to Šakiai GMS Exit Point is granted (i.e. once the restricted capacity at Kotlovka GMS Entry Point is booked and natural gas is injected through that point by using a restricted capacity product, the natural gas must be further transported and ejected only through Šakiai GMS Exit Point (without possibility of delivering natural gas to the other points and (or) selling it at a virtual natural gas trading point (natural gas exchange)).
